Artwork submission guidelines

Artists are invited to submit images of up to four (4) pieces of **original artwork** for consideration. Notes:

** All artwork must be available for sale

** Please do not submit pieces that have been selected for a previous UNCLAD show

Applications are due: **January 15th, 2010**. Please include the following:

- 1) Digital images (JPG format) or slides**
- 2) Enclosed Entry Form**
- 3) \$ 25 flat entry fee (payable to "Gallery by the Bay")**
- 4) Resume/biography**

Note: Artist biographical information and images of accepted artwork will be used for publicity purposes and may be displayed online on the Uncladart.com and gallerybythebay.com web sites and various social media tools used to promote the show.

Artwork Delivery & Pickup

The artist is responsible for delivering accepted artwork to Galley by the Bay and for picking up any unsold work. Artists who ship their artwork must make arrangements for return shipping.

Insurance

The gallery will take every reasonable precaution to ensure the safety of artwork during the show, however we do not provide insurance for the artwork.

Commissions

The Gallery will take a 40% commission on sales in the Juried Fine Art Show. Artists will receive a check for sold artwork within two weeks of the end of the show.

Gift Shop

The Unclad gift shop is a special area for prints, cards, jewelry, and other gift items. All gift shop items must relate to the theme "Unclad – The Fine Art of the Figure." The Gallery will take a 40% commission on all Gift Shop sales.
